INTRODUCTORY ITEMS

Attendees introduced themselves. Dr. Johnny Peebles III made a motion to approve the March 17, 2010 meeting minutes. Ms. Peggy Cochran seconded the motion that passed on a voice vote.

Mr. Bill Foisy presented a report on MPO actions. The MPO Subcommittee received a report from the TIP Subcommittee. The annual Rideshare program was authorized. The TIP Subcommittee is working to establish a resurfacing program for smaller governments to utilize. The MPO has received a request for funding from Norfolk Southern for the Intermodal Facility in McCalla. The RPC is currently determining eligibility before sending to the TIP Subcommittee and the MPO Committees. TIGER II planning grant information was presented to the MPO Subcommittee. The RPC will be pursuing money to complete a comprehensive plan for the McCalla area.

Questions asked in relation to the projects included the following:

Is the I-65 rehabilitation in the northbound direction or the southbound direction? If the estimates go higher, will the projects have to be revisited? What is the grade of the concrete? Can the jobs be monitored to determine that there are no illegals performing work? Will rehabilitation be done on 459 due to unsatisfactory previous work? Will I-65 work be continuous to the Shelby County portion?

A request was made for a copy of the 40CFR 93.126 Table 2, referenced in the tables.

Mr. Phillip Wiedmeyer made a motion to recommend approval of the TIP modification. Dr. Johnny Peebles III seconded the motion that passed on a voice vote.

UNIFIED PLANNING WORK PROGRAM

Mr. Bill Foisy presented a request to modify the 2010 Unified Planning Work Program to incur PL expenses of approximately \$13,600 federal for strategic planning activities in support of the development of the Transit Development Program (TDP).

The adopted FY 2010 Unified Planning Work Program includes the following task:

• Task 6.3, Public Transit Planning, Including Transit Development Program
Task A., Short-Range Transit Planning – Transit Authority Planning Assistance;
Conduct continuing planning assistance to the BJCTA concerning the TDP update, program maintenance, and program implementation.

Task A would be modified to read as follows:

Update Transit Development Plan. Update the existing Transit Development Plan and Operations Analysis to refine maps, evaluate transit routes, and identify both passenger and system-wide needs. The plan update will consist of multiple phases to be accomplished over the course of two fiscal years. The plan update will also standardize the plan horizon to more closely match with the metropolitan transportation plan horizon as well as adjustments to better coordinate TDP recommendations with regional transportation plan recommendations. Phase 1 activities will occur in FY 2010 and are described below:

Vision and Goal Setting – Transit Board of Directors

The Birmingham-Jefferson County Transit Authority's Board of Directors will be engaged in a strategic planning session in order to develop an updated vision for the transit system's future given the existing and expected financial constraints, as well as the desired condition of the Authority. This will be followed by the establishment of specific goals and SMART (Specific, Measurable, Agree-Upon, Realistic, and Time-Bound) objectives for achieving the articulated vision.

Deliverable: Strategic Plan and Action Report for input to Chapter 1 of the TDP.

Vision and Goal Setting – Key Stakeholders (Funding Partners)

The Birmingham-Jefferson County Transit Authority's funding partners (i.e. participating municipalities and contract agencies) will be engaged through stakeholder interviews and/or focus groups in order to obtain information about their perspective of the transit authority's existing operations, their vision/desires for public transit services as it relates to the region, and their desires for transit system funding. Stakeholder inputs will be used to inform the development of specific goals and SMART objectives for achieving the articulated vision.

Deliverable: Stakeholder Interview Summary Report for input to Chapter 1 of the TDP.

Vision and Goal Setting – Partnering Agencies/Committees

The Birmingham-Jefferson County Transit Authority's partnering agencies and committees (i.e. the BJCTA Transit Advisory Committee, BJCTA VIP Advisory Committee, Regional Planning Commission of Greater Birmingham/Birmingham Metropolitan Planning Organization, Jefferson County Department of Public Health, Birmingham Business Alliance, Blue Ribbon Transit Committee, etc). will be engaged through one on one stakeholder interviews in order to obtain perspectives about the transit authority 's existing operations, and to gather their vision/desires for public transit services as it relates to the region. Stakeholder inputs will be used to inform the development of specific goals and SMART objectives for achieving the articulated vision.

Deliverable: Partnering Agency/Committees Summary Report for input to Chapter 1 of the TDP.

Vision and Goal Setting - Riders

The Birmingham-Jefferson County Transit Authority's riders will be engaged through public outreach activities in order to obtain input to the development of the BJCTA's vision for the provision of public transit services. Rider input also will be used to inform the development of specific goals and SMART objectives for achieving the vision.

Deliverable: Rider Input Summary Report for input to Chapter 1 of the TDP.

Staffing for Task A will include the Birmingham-Jefferson County Transit Authority, the Regional Planning Commission of Greater Birmingham and a contract employee.

Mr. Phillip Wiedmeyer made a motion to recommend modification of the UPWP. Dr. Johnny Peebles II seconded the motion that passed on a voice vote.

PROPOSED NEW OZONE STANDARDS BY THE EPA

Mr. Dale Hurst presented information on the new proposed ozone standards that are expected to be announced by the Environmental Protection Agency (EPA) in August. Information presented included the following:

Ground level Ozone – What is it?

- Ground level ozone not stratospheric ozone.
- Colorless gas formed on dry, sunny, hot, stagnant days April October
- Primarily a problem in and near metropolitan areas
- Not directly emitted
- Pollutants which form ozone come from many sources

Revised Ozone NAAQS

• On January 6, 2010, EPA proposed to strengthen the national ambient air quality standards (NAAQS) for ground-level ozone. EPA is proposing to tighten the 8-hour "primary" ozone standard, designed to protect public health, to a level within the range of 60 - 70 ppb.

Nonattainment: Formal designation by EPA that an area does not meet a standard or that it contributes to an area not meeting the standard.

By State and Federal law, EPA has total authority over the standards and for setting boundaries of non-attainment areas.

Consequences of Nonattainment

- Considered to have unhealthy air
- Transportation planning must consider air quality impacts
- Obstacles to growth of large new industries

Determining Nonattainment Area Boundaries

• EPA's presumptive ozone nonattainment area boundaries can include:

- all counties in a consolidated metropolitan statistical area (CMSA) with a violating ozone monitor, and
- all counties in a metropolitan statistical area (MSA) with a violating ozone monitor.

Revised Ozone NAAQS

Most areas will rely on nationally mandated control measures to achieve the revised ozone NAAQS.

SCHOOL AIR TOXICS SAMPLING IN JEFFERSON COUNTY

Mr. Corey Masuca of the Jefferson County Department of Health presented a report on the school air toxics sampling that was conducted in 2009 in relation to a USA Today report. Information presented included the following:

- November 2008 USA Today completed a study ranking the relative exposures of students (128,000 schools) to air toxic pollutants
- EPA and JCDH initiative
 - 4 schools in Jefferson County
 - Birmingham Lewis Elementary, North Birmingham, and Riggins Elementary
 - Tarrant Tarrant Elementary
 - Selection based on proximity to risk driver Coke Oven Emissions
- What is an air toxic pollutant?
 - Not a criteria pollutant (NOx, SO2, CO, particulate matter, ozone)
 - Carcinogenic in nature
 - USEPA Clean Air Act 187 different pollutants
 - Sources
 - Combustion of fuels
 - Cigarette smoke
 - Factories, plants
 - Autobody shops
 - Gasoline stations
 - Chemical processes
 - Etc.

• Examples

- Perchloroethylene
- Benzene
- Toluene
- Carbon Tetrachloride
- Acrolein
- Chromium
- Etc.

• Why children?

- Greater exposure Children spend more time outside
- Sensitive group Less-developed respiratory system

• Sampling Specifics

- Approx. 100 different pollutants
- Sampled every six days
- Sampled submitted for analysis
- Sampling Initiation August 2009
- Sampling Conclusion November 2009

Outreach

- Meetings with school officials
- Letters to parents of students in schools
- Attendance at community meetings

Results

- Sampled concentration comparisons with health-based screening levels
- Both acute (short-term) and chronic (long-term)
- Tentative exceedances of
 - Acrolein (long-term)
 - Several combustion sources
 - Present in numerous locations

Next Steps

- Continued met data sampling for extrapolation
- Comprehensive evaluation with EPA
- Potential additional monitoring for problems areas/pollutants
- Potential remedial actions
 - Anti-idling
 - Indoor Air Quality School kits (i.e., cleaning product alternatives, etc.)
 - Etc.
