CALL TO ORDER AND ROLL CALL

Chairman Abbott called the meeting to order at 1039 a.m. A quorum was declared by the Chairman.

MINUTES

FINANCE COMMITTEE

Mr. Brian O'Dell presented the financial reports ending September 30, 2017.

Statement of Net Assets

This report is a solid report representing more than adequate funding and cash flow for the Agency. The reporting represents consistent numbers. Cash and Cash Equivalents: Operating funds is \$997,080 and Reserve Funds is \$352,561. Total Current Assets are \$4,305,594 (C), Accounts Receivable are \$1,612,718 (F), Unbilled Receivables are \$1,289,565 (D), Total Current Liabilities are \$2,290,264 (E), Accounts Payable are \$1,479,906 (G), Deferred Revenues are \$671,667 (H).

Budget Summary

The budget summary reflects a majority of programs/projects are under the funding available when looking at J (Variance). STP Advance Planning is over budget for this reporting period and is due to the closeout of this agreement by the end of the Fiscal Year. There is sufficient funding to cover the overage.

Total Expenditures are under budget by \$1,368,631 (J), Salaries, Fringe and Indirect are under budget \$196,885 (K), Direct Costs and Contracts are under budget \$1,171,746 (L).

<u>Dues</u>

The Committee reviewed the Dues Status report for FY2018. A comparison chart was distributed indicating dues collected as of November 30, 2017. 58 member governments have paid \$359,630 during FY 2018 compared to 58 member governments paying \$389,930 for the same period last year (FY2017). The difference in the dollar amount is due to a billing glitch that has not been corrected and this money will be received soon.

COMMITTEE APPOINTMENTS

Mr. Ball announced that Ms. Joselyn Harper has requested to return to serve on a RPC Committee. She previously served on the Finance Committee. Mr. Ball recommends to
