# FOR JEFFERSON COUNTY, ALABAMA

1997 - 2006 The Movement of People and Income

Migration is an integral part of ascertaining the population change within a given area. It affects communities, whether they are neighborhoods, counties, or metropolitan areas, through an on-going exchange of people. Migration refers to the directional movement or relocation of people either into an area or away from an area and, as a component of population change, fluctuates over time. Through an analysis of migration patterns and the resulting transfer of wealth, conclusions may be drawn as to the reasons behind these patterns and the implications regarding employment and labor, the impacts to local budgets, and the effects of existing public policies.

This report is an analysis of migration trends in Jefferson County, Alabama. Using county-to-county migration data provided by the IRS, this report illustrates where people and wealth are moving to and from in Jefferson County. The data utilized tracts the movement of tax returns (migration) and aggregate adjusted gross income between 1997 and 2007. This analysis of Jefferson County includes:

- Migration flows by state
- Migration flows by selected metropolitan areas
- Migration flows between Jefferson County and other Alabama counties
- Income flows by state
- Income flows between Jefferson County and other Alabama counties

#### About the Data


Unless otherwise indicated, the data for this report are from Internal Revenue Service County-to-County Migration files for the years 1997 to 2006. These data include the number of returns (migration) and total adjusted gross income. Average wages are estimated by average income per return. No estimate is provided as to fiscal impacts due to taxes on disposable income. IRS totals may not be the same due to "other" geographic catagories where data cannot be georeferenced.


The files are based upon income tax returns aggregated between consecutive years. According to the IRS, the estimates capture about 80-85% of the population of an area. The data used is for informational purposes and should only be used for analysing trends and data comparisons. The data should not be used for official population estimates or fiscal policy-making decisions.

Jefferson County gained residents from 38 states (excluding Alabama) and the District of Columbia between 1997 and 2006, totaling 31,692 persons, while losing 34,295 residents to 37 states and the District of Columbia. The majority of migration inflows comes from the Southeast, with 6,088 persons moving to Jefferson County from the State of Georgia, 5,383 from Florida,3,071 from Tennessee, and 2,385 from Mississippi. Migration inflows from Southeastern states totaled over 21,600, comprising 68% of all migration inflows.

States receiving the greatest numbers of out migration include Georgia with 8,626, Florida with 5,933, and Tennessee with 3,343. Southeastern states were also the primary desinations for residents moving from Jefferson County, totaling nearly 23,000 or 67% of all destinations.

Foreign inflows exceeded foreign outflows in Jefferson County, with 3,370 persons migrating into the county while 1,276 migrated out to live abroad.





Between 1997 and 2006, migration flows into Jefferson County averaged 11,814 residents while migration outflows averaged 12,884 residents. The resulting average annual net loss of 1,070 residents may have a long term effect on the population estimates for Jefferson County, but it represents less than 1% of the county's population. Other factors such as birth and death rates will overshadow that loss, making it essentially statistically insignificant in terms of overall impact.

The implications of this trend, however, have a broader impact on the County's economic well being, exisiting and future business retention, and tax base. While the flows of migration into and out of Jefferson County have remained relatively constant and with little impact, the population trends estimated by the U.S. Census Bureau illustrate a slow but steady decline in the resident population.

#### **Common Migration Terms**



In Migration - Migration into an area during a given period of time. A migration inflow is in migration to a particular Net Migration - The difference between in migration and area.

Out Migration - Migration out of an area during a given more migrants entered an area than left an area during period of time. A migration outflow is out migration from that time. A negative net, or net out migration, means a particular area.

Migration flows - Refers to the directional movement or Gross Migration - Refers to the sum of in migration and out relocation of the resident population, either into or out of migration, or inflow and outflow, for an area for a given period of time. This is a measure of the total amount of movement in and out of an area.

> out migration, or inflow and outflow, during a given period of time. A positive net, or net in migration, indicates that more migrants moved out of an area than entered it.




#### METRO MIGRATION INTO JEFFERSON COUNTY

Between 1997 and 2006, Jefferson County received over 83,000 immigrants into the county from 135 metropolitan areas across the nation, including those within the State of Alabama. As illustrated below, the majority of inflows from outside the state occur within neighboring states, however, the majority of all inflows come from within the State's own metropolitan areas and especially from counties within the Birmingham-Hoover MSA.

The chart at right identifies the top 20 origins of Jefferson County migration inflows. Over 31,000 of all inflows originated within Birmingham-Hoover MSA counties. From these top 20 origin MSA's, 10 of Alabama's 11 MSA's are represented. Outside the state, the Atlanta metro area was the origin of the majority of out-of-state inflows, however the total only consisted of 6% of total inflows. Other out-of-state MSA's that made notable contributions to Jefferson County inflows were the Nashville, New Orleans, Chicago, and Dallas MSA's.




#### METRO MIGRATION OUT OF JEFFERSON COUNTY

The migration outflows between 1997 and 2006 totaled nearly 99,000 residents moving to other metropolitan areas across the nation, including those within the State of Alabama. Similary to the inflows, the majority of outflows going outside the state occur within neighboring states. However, the majority of all outflows from Jefferson County, nearly 49,000 or 49% are locating within other Birmingham-Hoover metro area counties.

The chart at right identifies the top 20 destinations of Jefferson County migration outflows. From these top 20 destination MSA's, 9 of Alabama's 11 MSA's are represented. Outside the state, the Atlanta metro area was the destination of the majority of out-of-state outflows, consisting of 8% of total outflows. Other out-of-state MSA's that received residents from Jefferson County include Nashville, Dallas, Washington D.C., Tampa, Pensacola, and Houston MSA's. The total outflows to out-of-state MSA's make up about 34% of all migration outflows from Jefferson County.



## JEFFERSON COUNTY NET MIGRATION BY COUNTIES, 1997 - 2006

The migration flows within Alabama, between Jefferson County and other counties, are more pronounced and imply a more localized economic connection. The flows in and out of Jefferson County make up the largest percentages of migration. Jefferson County received about 62,600 residents from Alabama counties between 1997 and 2006, with the majority coming from Shelby County with nearly 18,000.

The map at right identifies the net migration of Jefferson County to and from all other Alabama counties. As shown, Jefferson County lost more residents to Shelby County than any other, with other outlaying counties also receiving residents from Jefferson County. Conversely, Jefferson County gained residents from the metro counties of Tuscaloosa, Montgomery, and Mobile.






The transfer of taxable income flowing into and out of Jefferson County between 1997 and 2006 has had financial impacts on the county and municipal economies. Over the decade, the income flows into the County totaled \$4.7 billion while the outflows totaled \$5.6 billion, resulting in a net loss of about \$920 million, or an average annual net loss of \$92 million.

Income flows from other states entering Jefferson County totaled \$2.3 billion while \$2.4 billion left the County for other states. These exchanges have occured primarly between states in the southeast where income transfers both to and from Jefferson County make up 70% of all income transfer activity. The majority of income transfers, however, occur within the State of Alabama, with \$2.4 billion entering Jefferson County from other Alabama counties, but \$3.2 billion moving out of Jefferson County for other counties. Income transfers within the State of Alabama make up more than half of all income transfer activity.





Between 1997 and 2006, Jefferson County has experienced a modest increase in the annual totals of taxable income flowing into and out of the County. These increases are consistent with the cost of living and wage and salary adjustments made over time.

The average taxable income of the out-going population is about \$44,000 while the average taxable income of the population moving into Jefferson County is about \$40,000. These averages imply that the County is losing higher paid workers to other counties, and as such, is losing a larger share of taxable income, whether that be in the form of ad valorum tax, sales tax, or other taxes on disposable income.




Out of state income transfers indicate a net loss of nearly \$92 million over a ten year period. Foreign immigration resulted in a positive net transfer of totaling nearly \$3 million. The largest net loss of income transfer has occurred within the State of Alabama, with nearly \$830 million being lost to other Alabama counties from Jefferson County.



### JEFFERSON COUNTY NET INCOME TRANSFER BY COUNTIES, 1997 - 2006

Income transfers between Jefferson County and other Alabama counties make up over half of all income transfer activity, particularly between adjacent counties within the Birmingham-Hoover Metropolitan area. Much of the taxable income loss from Jefferson County is not lost to other states, but rather to adjacent counties and other Alabama metro areas.

The map at right identifies the net income transfers of Jefferson County to and from all other Alabama counties. As shown, Jefferson County lost more taxable income to Shelby and St. Clair counties, with other outlaying counties also receiving taxable incomes from Jefferson County. Conversely, Jefferson County gained taxable incomes from counties including Mobile, Montgomery, Tuscaloosa, Etowah, and Calhoun.
